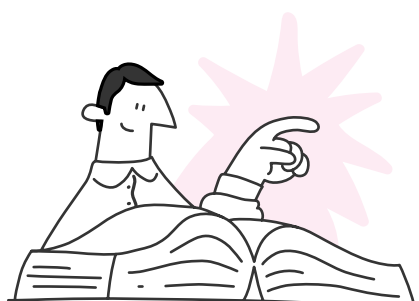

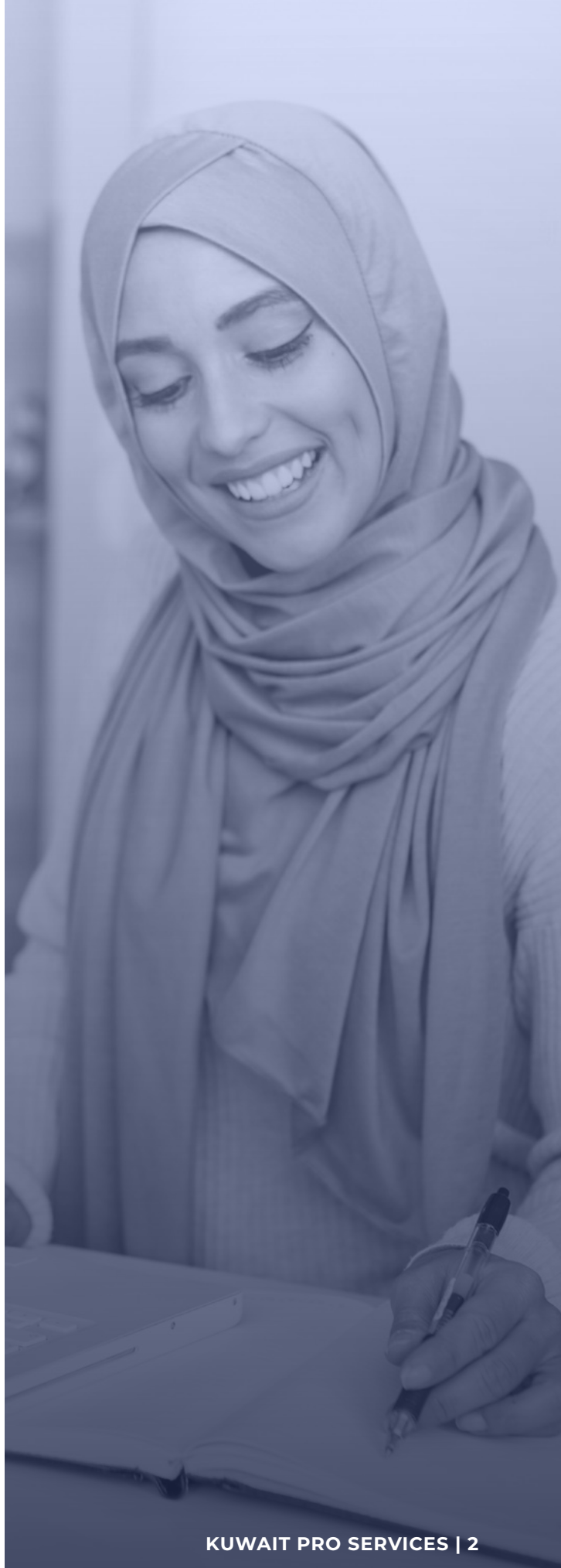

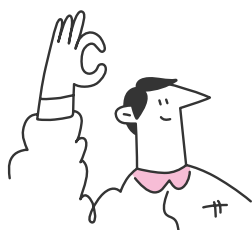
Company Name Reservation

Applying for a commercial license is a crucial step in the company registration process. PROs prepare and submit the commercial license application to the MOCI, along with all required documents and approvals.



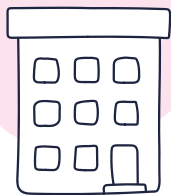
Registration with the KCCI
