LEGAL REQUIREMENTS FOR EMPLOYERS IN KUWAIT

In Kuwait, employers must comply with several legal requirements to operate legally and responsibly.

These include:

1. Legal Entity Registration:

Employers must be registered as legal entities with the Chamber of Commerce in Kuwait. This ensures that they are recognized and authorized to conduct business within the country.

3. Local Manpower Employment:

Employers must show their ability to hire local manpower, aligning with government initiatives to boost employment among Kuwaiti nationals. The Ministry of Social Affairs and Labor enforces a quota system to ensure a certain percentage of employees are Kuwaiti nationals.

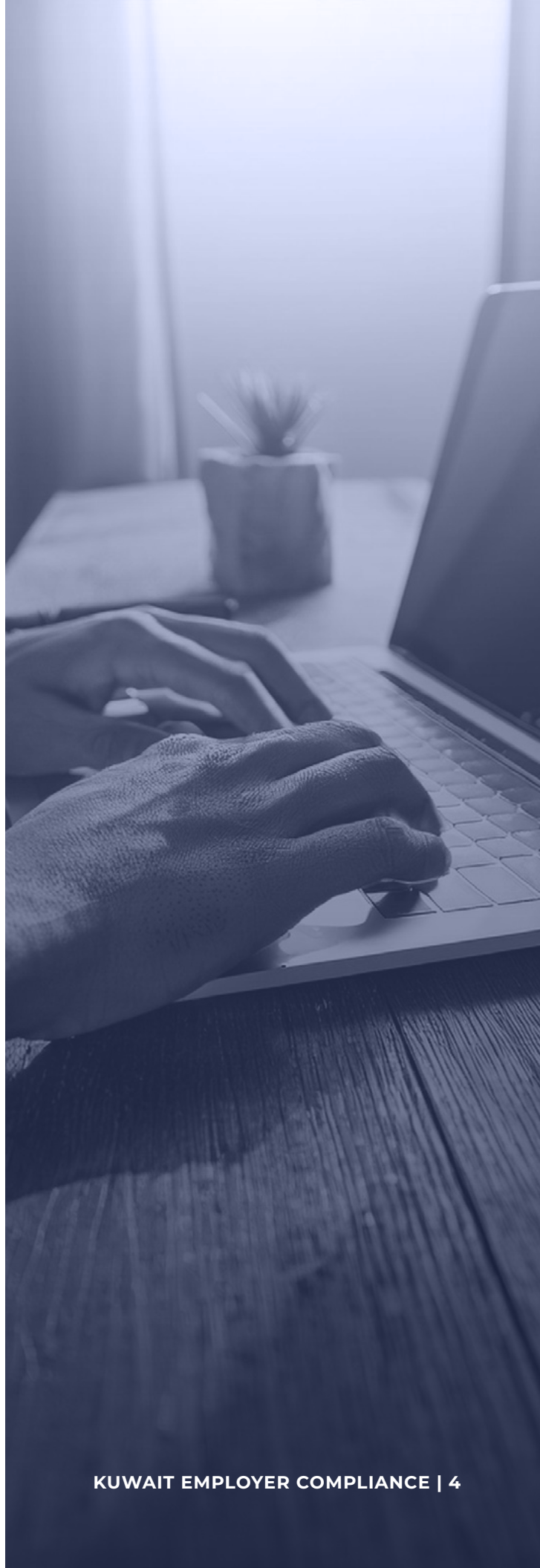
